DEPOSIT & GUEST COUNT

ALL ORDERS REQUIRE A 50% DEPOSIT AT THE TIME OF BOOKING AND A SET MINIMUM GUEST COUNT. THE FINAL PAYMENT IS DUE ONE WEEK BEFORE THE ORDER DATE, ALONG WITH FINAL GUEST OUT. THIS DEPOSIT IS NON-REFUNDABLE.

PRODUCTS AND AVAILABILITY

CANCELLATION POLICY

50% OF THE ENTIRE BILL (INCLUDING, BUT NOT LIMITED TO: CATERED FOOD, EQUIPMENT RENTAL, ROOM RENTAL, LABOR) IS DUE TO CONFIRM AN EVENT. THIS DEPOSIT IS NON-REFUNDABLE. THE REMAINING 50% OF THE BILL IS DUE 7 DAYS PRIOR TO THE EVENT.

UP TO AND INCLUDING 7 DAYS PRIOR TO EVENT, THE REMAINING 50% OF THE BILL IS REFUNDABLE IF THE EVENT IS CANCELLED. 6 DAYS PRIOR TO AND INCLUDING THE DAY OF THE EVENT, 100% OF THE BILL IS NON-REFUNDABLE.

** NOTE: REFUNDS ARE THE SOLE DISCRETION OF BOWERMAN'S ON 8TH. ALTHOUGH AN EVENT MAY BE CANCELLED OR RESCHEDULED, BOWERMAN'S ON 8TH RESERVES THE RIGHT TO DETERMINE CANCELLATION OR REFUND TERMS.

DAMAGE / THEFT POLICY
